This agreement contains terms and conditions that apply to your purchase from MDC Group. These terms and conditions apply (i) unless the buyer has signed a separate purchase agreement with MDC Group in which case the separate agreement shall govern; or (ii) unless other MDC Group standard terms apply to the transactions.

By signing this document, Buyer is affirming that he/she has the authority to enter this Agreement and intends to be bound by it. Buyer agrees to purchase vacation awards from MDC Group at the price and quantity, and upon the payment terms set forth in this Agreement. Buyer agrees that vacation awards are for use solely as a promotional tool and are not to be resold. The vacation awards may be redeemed only during the designated redemption period indicated on the vacation certificate. Buyer acknowledges that the vacation awards are nonrefundable. MDC Group's program is designed as a drive-away / get-away vacation award.

Other Documents: These terms and conditions may not be altered, supplemented or amended by the use of any other document(s) except as otherwise noted. Any modification of this Agreement must be in writing, signed by both parties.

Governing Law: This Agreement and any sales hereunder shall be governed by the laws of the state of Florida. Any other representation, inducements or promises not stated herein shall have no binding effect. In the event of a dispute regarding the terms of this agreement, venue for litigation shall be Pinellas County, Florida and the prevailing party shall be entitled to be reimbursed for reasonable attorney's fees and costs.

Payment Terms: Terms of payment are within MDC Group's sole discretion. Unless otherwise agreed to by MDC Group, payment must be received prior to MDC Group releasing any products. Payment for the products shall be made by check or credit card. Invoices are due and payable within the time period noted on the invoice, measured from the date of the invoice. MDC Group may invoice parts of an order separately. Buyer agrees and expressly understands that vacation awards will not be released or redeemed unless all invoices are paid in accordance with the terms set forth on page five.

Delinquent Accounts: In the event payment is not made when due hereunder, interest on the outstanding balance will accrue at a rate of 1.5% per month. Upon delinquency all vacation awards that had been released will be put on hold until the account is brought current.

Products: In an effort to consistently provide the highest quality products, MDC Group regularly revises/updates resort destinations and cruise selections. In the event a particular product is revised or discontinued, MDC Group will provide products of equal or greater value and will make every effort to inform Buyer of any changes to product(s) purchased by Buyer.

Loss/Exchange of Vacation Award: In the event a vacation award is misplaced, lost, or stolen a replacement may be issued at an additional charge. This option is available for the Advantage Awards only. The fee is payable at the time the request is made. No awards will be shipped unless payment is made in advance.

Limitation of Liability: MDC Group's liability for any breach of this Agreement is limited to those rights conferred to the Buyer hereunder. Buyer agrees that the sole remedy for any breach of this Agreement or nondelivery of products and/or services shall be a refund of the purchase price paid by the Buyer and received by MDC Group for those services only. Buyer agrees that MDC Group shall not be liable for any loss, damage or injury, either personal or business, arising from the use of this product. MDC Group Inc. reserves the right to use Buyer's company name and/or logo for reference and marketing purposes. Buyer's contact information will not be given out without their permission.

Force Majeure: MDC Group shall not be responsible for delays or failure to perform caused by strikes, government rules, orders, laws or regulations, the existence of unusual market conditions or by flood, fire, delays of carriers and acts of God, acts of foreign governments, or other similar occurrences beyond the control of MDC Group.

Electronic Communications: By providing an e-mail address and fax number on page one of this Agreement, Buyer agrees to receive subsequent communications from MDC Group relating to product updates, invoices, statements of account, proofs of marketing materials if appropriate, promotional offerings and other items via e-mail or facsimile transmission at MDC Group by faxing written notice of such decision to MDC Group at 727-771-0927.

This agreement is subject to corporate approval by MDC Group Inc. Buyer hereby expressly acknowledges that this Purchase Agreement shall become binding and enforceable upon written approval and acceptance of same by the authorized, undersigned executive representative at MDC Group's corporate headquarters. Buyer further agrees that MDC Group Inc. is not bound by the terms of the Purchase Agreement by virtue of the signature(s) of MDC Group's Independent Sales Representatives and/or Customer Service Representative hereupon unless the signature is that of an officer of MDC Group Inc.

In the event that Buyer breaches any of the terms and conditions set forth in the Purchase Agreement, Buyer acknowledges and agrees that it shall be liable to MDC Group for any contractual damages resulting from such breach, including lost profits, and other foreseeable, consequential damages.
